## Sub: Furnishing of PAN, KYC details and Nomination by holders of physical Securities

SEBI has vide Circular No. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/655 dated November 3, 2021 read with SEBI/HO/MIRSD/MIRSD\_RTAMB/P/ CIR/2021/687 dated December 14, 2021 and SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 mandated furnishing of details of PAN, email address, mobile number, bank account and nomination by holders of physical securities. Further, it is stated that folios wherein any one of the cited document / details are not furnished or made available **on or after October 1, 2023**, the relevant folio(s) shall be frozen by the Registrars and Transfer Agent of the Company (RTA) and such frozen folios were required to be eventually referred to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and / or Prevention of Money Laundering Act, 2002, after **December 31, 2025**.

In order to mitigate unintended challenges on account of freezing of folios and referring frozen folios to the administering authority under the aforesaid Acts, SEBI, vide its Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2023/181 dated November 17, 2023, has done away with the provision regarding freezing of folios lacking PAN, KYC, and Nomination details.

All shareholders who have not furnished the documents/details viz., PAN, E-mail address, mobile number, bank account and nomination are requested to send the documents given below:

- PAN, Address, Email Address, Mobile Number, Demat account details and Bank Account details should be furnished in Form No. <u>ISR 1</u>
- Confirmation of Signature of securities holder by Banker in Form No. <u>ISR 2</u>
- Declaration for Opting-out of Nomination by holder of physical securities in Form No. <u>ISR 3</u>
- Nomination details should be furnished in Form <u>SH-13</u> and for cancellation or variation of Nomination in Form No. <u>SH-14</u>
